
SECTION-I
TECHNICAL SPECIFICATION/SCOPE OF WORK

1. GENERAL DESCRIPTION

- 1.1 Mechanical Maintenance Section(MMS)/Baina, MPA intends to obtain budgetary quotation for "Dismantling /assessment/servicing/repairing/ overhauling /refitting / testing & commissioning of 3nos. hydraulic directional control valves on Maniar make hydraulic elevated platform (model-EP-15 Mtr) installed on TATA make & model no.909 pick up.
- 1.2 The above hydraulic elevated platform (Model-EP-15 Mtr) was procured from M/s.Maniar & Co. Ahmedabad in the year 2010 and is used to carry out day to day maintenance / repairs of electrical works in and around the Port.
- 1.3 The hydraulic elevated platform is more than 12 years old, recently, during routine maintenance of the hydraulic line assembly system, it is noticed that there was a heavy hydraulic oil leakages from the directional control valves of hoist/lower, slewing and out riggers during operations. Hence, all these directional hydraulic control valves.(2 way, 4 way and 5 way valves) of the hydraulic system needs servicing/repairing/ overhauling.
- 1.4 The detailed drawings of the hydraulic line and elevated platform assembly is enclosed at **Annexure-I** and photos of the hydraulic elevated platform along with control valves enclosed at **Annexure-II** .
- 1.5 The contractor should visit MMS section Baina to assess/inspection of the conditions of hydraulic line system before quoting to gauge the quantum of work involved. The assessment / inspections of the system shall be carried out at MMS/Baina, MPA.
- 1.6 The rates quoted at **PRICE SCHEDULE (BILL OF QUANTITIES – BOQ)** shall be inclusive of dismantling of the three (3) hydraulic directional control valves, servicing/repairing /overhauling/refitting / testing & commissioning of these hydraulic control valves on Maniar make hydraulic elevated platform (model-EP-15 Mtr) installed on TATA make & model no.909.
- 1.7 The contractor should quote the rate by taking into consideration all expenses till the successful commissioning and trials of the hydraulic line system of hydraulic elevated platform (model-EP-15 Mtr).
- 1.8 The entire work shall be completed within one week from the date of issue of LOA.

- 1.9 The hydraulic line system shall be guaranteed for 12 months for trouble free operations from the date of successful commissioning and handing over to the Port. If any defect is observed during the guarantee period, the same shall be repaired /overhauled/rectified by the Contractor, free of cost under guarantee obligations.
- 1.10 90% of the billed amount shall be paid within 30 days from the date of receipt of undisputed bill and the balance 10% shall be retained as security deposit for a period of 12 months to fulfil the guarantee obligations.
