1. Mormugao Port Authority, Goa:

Mormugao Port, commissioned in 1885 is one of the oldest ports on the west coast of India in the state of Goa and is blessed with a protected open type natural harbour. Over the years, it has developed a deep draft channel. With its location at the mouth of the Zuari River, it is a crucial component in the flourishing export industry of the state of Goa. It became one amongst the major ports of the country in 1964 and has been relentlessly serving the nation in its economic development.

2. Objective:

Mormugao Port Authority, Goa intends to establish a Superyatch parking facility inside the port water limits, with the objective of providing integrated infrastructure Facilities and strengthen the superyatch traffic through the Port. The scheme envisages linking groups of producers to the processors and market. The details of the Port limits is provided in the annexed sketch and location map. (Annexure I)

3. Broad Scope of Work:

The scope of components of establishing a Superyatch parking facility inside the port water limits includes only allocation of a waterfront area by the Port to the land parcel adjoining the Port waters. Port shall be providing its water front area and shall not providing any land parcel. This land parcel has to be arranged by the prospective bidder. Usage of Scope has been deliberately kept broad based to allow flexibility in project planning. The prospective bidders are free to propose the facilities, infrastructure, mode of handling etc.

- a. As shown in Annexure I, the Port limits has access to Arabian Sea / Zuari River. The approaches can be made available for ingress and egress by Sea, Road, Rail an Inland Waterways.
- b. The provisions of Public Procurement (Preference for Make in India) order 2017 and subsequent amendments shall be applicable.
- c. Facilities can be set up by individuals or group of entrepreneurs or companies with business interest to establish a Superyatch parking facility inside the port water limits and also by those who are involved in the business as specified in the broad scope of work above.
- d. Port shall be providing its water front area and shall not providing any land parcel. This land parcel has to be arranged by the prospective bidder. The allocation by the Port shall be on 30-year Tender process on PPP basis under Model Concession Agreement of Ministry of Ports, Shipping & Waterways. The proposals should indicate the credentials of the promoters, tentative business plan and other related details along with viability of the project. The application should be submitted in the prescribed format as per Annexure-II & III. No Applicant may apply more than once either as an individual or as part of an entity. Multiple applications of same Applicant will not be evaluated. The shortlisted applicants will make a detailed Presentation before the Port subsequently the date and time of the same will be communicated later.
- e. Proposals for land parcel allocation within the Port may also be submitted by the prospective bidders, however this shall not be binding on the Mormugao Port in any form.

4. Award of Work:

On the basis of the information collected during evaluation of the EOI, the prospective bidders will participate in the tender on PPP basis under Model Concession Agreement of Ministry of Ports, Shipping & Waterways for the land. The facility at the site should start its commercial operations within 18 months of the taking possession.

5. Final decision making authority:

MOPA reserves the right to accept or reject any application and to annul the process and reject all applications at any time without assigning any reason thereof and without thereby incurring any liability to the affected applicant or without informing the applicants of the grounds for such action by MOPA.

6. Submission Requirement:

The applicants shall provide documentary evidence to MOPA of their proposal and their capability and adequacy. In addition, while applying for this EoI, the applications shall include the following information:

- ii. Letter of Interest and Annexure-'Ill'.

7. Language of Application:

The language of the Application shall be in English only.

8. Submission of EOI:


The EOI must be submitted by EMAIL OR online through CPP Portal.
