- 1. Only tenderers having experience in supplying of Medical Equipment's are eligible to apply for this Tender.**

- The Bidder shall furnish the requisite EMD, until and unless is exempted for being an MSE vendor. Without EMD, for those not exempted, their offer shall be treated invalid. In the event of Bidder withdrawing his tender before the expiry of tender validity period of 120 days from the date of opening of techno-commercial bid (Cover-I), the tender submitted by the Bidder shall be cancelled and EMD shall be forfeited. The EMD of unsuccessful Bidders shall be returned on award of Contract to the successful Bidder. No interest shall be payable on the amount of EMD in any case. The Earnest Money Deposit of the successful Bidder shall be refunded only on receipt of Security Deposit as stipulated in the tender. 17. **CONCILIATION:** If such meeting does not take place within 15 (fifteen) days period or the Dispute is not amicably settled within 15 (fifteen) days of the meeting or the Dispute is not resolved as evidenced by the signing of written terms of settlement within 30 (thirty) days of the notice in writing referred to in Clause (16) or such longer period as may be mutually agreed by the parties, either parties may agree to refer the Dispute to Conciliation & Settlement Committee **constituted by the Indian Ports Association and approved and appointed by the Board of Mormugao Port Authority** as per the provisions of the Arbitration & Conciliation (Amended) Act, 2015.
