The bidder should possess strong technical skills and knowledge to develop immersive and interactive VR Experiences. The bidder should have successfully executed production of 360 degrees Virtual Reality (VR) 3D Video in any State/Central Govt. / PSU's and reputed private organizations and it should be supported with documentary evidence.

OUTLINE OF THE CONTENT

The Content needs to be creative highlighting Port's core domain functions and should be made in a way that it shows smooth transitions from one area to another thus highlighting the clear coastline & other zones of the port.

- 1. "High Dynamic Range" Imagery video that will create greater visual clarity of the images / videos. It will make all the areas of the images visible with greater clarity. Like it looks to the eye.
- 2. The 4K resolution video shall be a combination of images, video clippings, animation with and without voice over in English as well as Hindi. The video shall contain information and highlight the key features or activities or heritage of the port. The port must cover complete activities of the port in a 7-10 minute video, including a voice over who will explain the journey of the port. High resolution imagery with advanced post processing for creating a seamless wrapped sphere.
- 3. Strategic mapping of spots on location to give maximum advantage and experience in 360* 360 degree.
- 4. It should be ensured that the volumetric content should be created in such a way to enable the VR application to provide emerging depth perception.
- 5. The video should be shot in proper lighting, without any burnouts and flares caused by sunlight and should have the same clarity in the Field of view(FOV)
- 6. The potential venue challenges should be accessed prior to the shoot and the light & sound with potential obstacles corrective steps to be taken accordingly to ensure clean footage.
- 7. The equipment to be used should include 360-degree camera, tripod, camera mounts, specialized 360 rigs, microphones, and lighting equipment if necessary.

CONTENT SHOULD FOCUS ON:

- 1. About the Port's core functions including its rich legacy of history
- 2. About the area of operations, coastline and the any specific natural features like corals, mangroves etc
- 3. About the unique feature or achievements of the Port
- 4. About the commercial activities at the port

HARDWARE UNDERSTANDING:

- 1. A Head Mounted headset, completely wireless that can handle a smart phone placement with smart phone size 5 inches.
- 2. The headset will be OS independent; it will be compatible with OS's like IOS, Android, Windows Phone OS and others.
- 3. To provide an immersive experience to the user, the FOV (Field of View) should be 100 degrees.
- 4. Lenses will have 45mm focal distance, asymmetric biconvex lenses with less than 0.1mm cosmetic defects.
