1	Cutting branches of 05 nos. trees which are identified by the Site Engineers. (Cutting of minimum 10 branches per tree) to be done by using wood cutting machine, for cutting only the branches which are posing danger to the Port property such as the AVC building structure and also to the Port compound wall and which are also posing threat to the safety of humans. Cutting of cut wood logs to proper manageable size and stacking neatly as per size and making arrangement to loading onto tippers/trucks etc and transporting the cut logs out of the Port area. Work to be executed using proper safety measures such as providing safety belts, ladders, ropes, tools required for cutting such as wood cutting machine, choppers, axe etc for execution all the works. All tools, equipment, machinery, vehicles and labour and material etc complete.
