
TERMS & CONDITIONS

2. The contractor shall take into consideration in his rates all expenses such as cost of materials, handling, transportation, shortage, wastage and loss, storage, watch and ward, cost of any equipments required for execution of the work such as cranes, etc.
3. Underwater and Tidal Works - The contractor will be deemed to have ascertained for himself the extent, to which the work has to be carried out underwater or in tidal conditions, and rates and prices shall include whatever allowance is considered by the contractor to be necessary for tidal conditions, lack of working area, etc.
4. The contractor shall keep at the site a standby generator, if required in running condition. The charges towards keeping and running a generator shall be included and no claim on account of any power failure shall be entertained.
5. Water and electricity will be supplied by the department from the nearest available point subject to availability at prevailing MPA rates. However if the same is not available, the contractor has to make his own arrangement at his own cost. The contractor shall as far as practice having regard to the conditions, provide on the site to the satisfaction of the Chief Engineer's Representatives, adequate supply of drinking water for the use of Contractor's Staff and Workmen etc.
