With reference to the above, Realistic Budgetary Offer is requested for “**Hiring of 02 No. Multipurpose Fire tender with manpower for a period of 7 years**” as per the scope of work & terms and conditions as follows:

Sr.No.	Description	Rate per day in INR
1	Hiring of 02 No. Multipurpose Fire tender with manpower for a period of 7years complying the Specifications given vide Annexure I .	

TERMS AND CONDITIONS:

1	The contract period is for Seven years (from the commencement of service).
2	Rate to be quoted without GST. The GST as applicable would be paid extra.
3	Income Tax as applicable shall be deducted from the bill.
4	The fuel, water, DCP and foam for running the Fire Tender will be supplied by MPA at free of cost .
5	The Fire Tender with staff shall be available with Mormugao Port Authority 24 hrs x 7 days basis (including weekly off / Public holidays).
6	Necessary Lubricants and other consumables required for running the Fire Tender shall be provided by the contractor at his own cost.
7	Fire Tender, shall be manned in each shift by qualified staff as per statutory regulations as follows: i) Fire Supervisor (skilled) – 1 No. ii) Leading fireman cum Fireman Driver cum Fireman (semiskilled) -6 Nos.
8	The Operator has to make arrangement for repatriation of staff at his own cost.
9	The Contractor shall not pay any Port charges .
10	Port entry passes will be issued free of cost for the operational staff, Managers and their vehicles.
11	The insurance for the staff and their vehicle shall be arranged by the Contractor.

	The Contractor shall take the insurance policy covering all type of risks of all employees engaged by them. The Employer Mormugao Port Authority (MPA) shall not be liable for any accident, death, injury, damage or compensation payable to any workman or other person in the employment of the Contractor or any Sub contractor.
12	Office / Store accommodation will be provided in the Port area, if available, on request on payment basis.
13	The Contractor has to comply with the Contract Labour Act, Workmen Compensation Act and shall follow the ESI & Provident Fund Rules for their personal/staff engaged. The contractor should also note that they should employ the staff of Indian Nationality only.
14	Any damages to the Port properties during Service repairs/rectification etc. will be at contractor's account.
15	Protection of Environment: All measures and aspects to be adopted to protect the environment. Safety Regulations: All personnel shall follow the safe working practice complying the safety guidelines.
16	All works must be carried out to the entire satisfaction of the Mormugao Port Authority.
17	Employer Liability Insurance: The Contractor shall indemnify and keep indemnified the Employer i.e. Mormugao Port Authority (MPA) against all damages or compensation payable at Law in respect of or in consequence of any accident or death or injury to any workman or other person in the employment of the contractor or Sub-Contractor against all claims, demands, proceedings, costs, charges and expenses whatsoever in respect thereof or in relation thereto and the Employer shall be at liberty to deduct or adjust from the Contractor's bills an amount that employer may be called upon to pay towards claims, demands, proceedings, costs, charges and expenses whatsoever in respect of or in relation to any accident or death or injury referred to above without any reference to the Contractor.
18	The Contractor shall comply with all extant Central, State and Municipal Laws and Rules and shall be solely responsible for complying with the provisions of the Contract Labour (Regulations & Abolition) Act, 1970 & the extant contract labour (Regulation & Abolition) Goa and rules there under and the enactments that may be applicable including ESI Act, the payment of wages act, Provident Fund Act, the Minimum Wages Act, the Factory's Act. The Workman Compensation Act or any other applicable legislation and the Municipal by-laws or other statutory Rules and Regulations whatsoever in force if these are applicable. Any obligations finding or otherwise missed under any statutory enactments, rules & regulations there under shall be the responsibility of the Contractor and the Mormugao Port Authority shall not be responsible for the same. The Contractor should take Workmen's Compensation Policy for his workers, who are not covered under ESI and submit the same to the EIC immediately after commencement of the work
19	The Contractor is liable to pay all Statutory Compensation of the Labourers / persons engaged by him for the satisfactory execution of the works. If any claim

	is made against Mormugao Port Authority on this work, the Port shall have the right to deduct the same from the bill amount payable to the contractor after verification of the validity and if admissible as per rules.
20	PERSONAL PROTECTIVE EQUIPMENTS: The contractor shall ensure proper use of PPE such as helmets, safety shoes, nose masks, hand gloves, Safety Harness, gumboots or any other equipment as required depending on nature of work by his staff at site.
21	The contractor shall arrange to provide complete uniform to the staff manning the Fire tender as per their Grades.

SECTION-I

TECHNICAL SCOPE OF WORK:

1. INTRODUCTION:

Mormugao Port Authority (MPA) intends to award the work on Turnkey basis for the hiring of 2 Nos. of Multipurpose Fire Tender with 14 nos. of certified man power in each shift 24*7 in 3 shift pattern for the period of 5 years.

2. The Multipurpose Fire Tender proposed to be hired would be manned with minimum 7 persons with designation of 1 no. of Fire Supervisor, 1. Leading Fireman, 5no. of Fire Fighter cum Driver operator. They shall carry out all the duties of the Fire Section including the duties on board Fire Tender & at Station level duties. And also to carry out maintenance of fire extinguisher in port area, standby duties at oil Berth as an when assigned by superior.
