SECTION-I

TECHNICAL SPECIFICATION/SCOPE OF WORK

1. GENERAL DESCRIPTION

- 1.1 Mechanical Maintenance Section(MMS)/Baina, MPA intends to obtain quotation from competent parties which are recognized by Inspectorate of Factories and Boilers, Panjim Goa, for carrying out annual load testing of 2 nos. EOT Cranes, 2nos. D Shackles, 2nos. wire rope slings and 2nos. pressure testing of air compressors at MMS/Baina workshop for the period of two years 2023-24.
- 1.2 MMS/Baina has 2 nos. EOT Cranes (50T Drted to 18T & 8T), 2nos. D Shackles(12T), 2nos. wire rope slings(12T) and 2nos. pressure testing of air compressors (250 & 160 ltrs). These equipments are used for lifting & moving heavy jobs as and when required.
- 1.3 As per mandatory requirement of Factories Act, the load testing EOT cranes and pressure testing of air compressors, D Shackles and wire rope slings are required to be carried out annually through Competent parties recognized by Inspectorate of Factories and Boilers and also the requirement is as per ISO.

2 SCOPE OF WORK

- **2.1** As per Factories & Boiler act, contractor shall carry out the tests, examination and inspection in accordance with the provision of the Act and rules.
- **2.2** The tests, examination and inspection shall be carried out under the direct supervision of the competent person or by a person so authorized by an institution recognized to be a competent.
- 2.3 On completion of tests, examination and inspection of the equipment, contractor shall submit the individual report of examination & test of equipment to MMS/Baina, MPA in the prescribed format as per act.

3. MINIMUM ELIGIBILITY CRITERIA:

Contractor shall furnish valid certificate of competency certificate for carrying out tests, examinations, inspection & certifications for lifts & hoists, lifting machines, lifting tackles and pressure plants issued Chief Inspector of Factories & Boiler, Panjim, Goa.

4. EVALUATION:

The evaluation shall be on the basic price (Total as per Price schedule / BOQ) and shall be considered lowest for testing all equipment's among all bidders. The rates offered shall be exclusive of GST. If any new tax imposed by the State/Central Govt., same shall be reimbursed by producing documentary proof.

5. PAYMENT TERMS:

- 5.1 Payment of 100% on pro-rata basis will be released within one month, on completion of each visit and after receipt of bills in duplicate along with the test reports/certificates duly signed by the contractor.
- **5.2** The payment will be released within 30 days for final bills from the date of receipt of undisputed bills in duplicate and with all other supporting documents.
- 5.3 Contractor shall furnish copy of the PAN card, GST Registration no.

5.4 BANK DETAILS:

The contractor shall furnish their bank account details for the payment through ECS by the MAP as per Annexure-II along with Bill for payment.

6. OTHER TERMS AND CONDITIONS:

- **6.1** The contract period is for two years 2023-24 (01 visit each year).
- **6.2** Load, Slings, Manpower etc required for testing the equipment's at MMS Baina will be provided by MPA during testing.
- **6.3** All tests shall be carried out in one day time, in case of power failure or any other unavoidable circumstances subsequent day may be granted.
- **6.4** Test certificate should be issued immediately after carrying out the testing.
- **6.5** The technical specification at Section I and Price Schedule (Bill of Quantities) at Section II to be read in conjunction to ensure the actual works involved.
