CIRCULAR

Sub: Waste Reception Facilities available at the Port of Mormugao

This Circular supercedes Circular No. DC/S-21/2007/46 dated June 08, 2007.

Waste Reception Facilities available at the Port of Mormugao are as follows:

1. OILY WASTES:

- a. Dumb Barge of 50 cu.m. capacity capable of receiving oily wastes/slops. To be paid for by Ship's Agents as per "Scale of Rates".
- Shore based tank of 5 cu.m. capacity for collection of oily bilge water from barges and other small crafts. This service is free of cost.
- c. By tanker lorries, arranged by licensed private contractor. The address/contact number of the contractor is as follows:

Ship's Agents may arrange for this service, which, at present is free of cost. Agents are requested to impress upon Masters to refrain from disposing off oily wastes to any other Company/persons other than those mentioned above, as it is likely to have severe legal implications.

2. SEWAGE:

Sewage reception facility is available only at berths. The Mormugao Municipal Council has a 3,000 ltrs. sewage truck with a 36 m. hose and suction/discharge pump. Ships can avail this facility at a nominal cost payable by Agents. A notice of 24 hrs. would be required by the M.M.C. However, if the sewage truck is idle, it can be sent to the vessel on a shorter notice.

Sewage collection from vessels to be carried out exclusively by Garbage Contractors licensed by the Port.

3. GARBAGE:

Ship's Agents may provide garbage collection service through private contractors licenced by the Port. The address/contact no. of the contractor is as follows:

Agents are requested to forward a copy of this circular (by fax, telex, e-mail etc.) to Masters of vessels, prior to their arrival at Mormugao, so that the reception facilities can be used during the vessels' stay in port.

Agents are also requested to ensure collection of the Ship Waste Assessment Form from all ships arriving at the Port of Mormugao for collection of data and assessment of adequacy of waste reception facility
