BACKGROUND:

Mormugao Port Trust is situated on the west coast of India. The Port is located at Mormugao , Vasco Goa. It is a beautiful natural Harbor and is more than 130 years old. The Port is operating under Ministry of Shipping, Government of India .

The Mormugao Port Trust has shifted its hospital to the new location at Headland, Sada, hence the old premises admeasuring 8026 sq.m along with the structure is available for development. The Port Trust intends to develop this land for the benefit of Port community, State of Goa and general public. As the old Hospital is facing the beautiful Baina beach stretch it can be developed into Hotels cum Restaurant.

The location plan showing the area admeasuring 8026 sq.m is enclosed with this document.

ELIGIBLE PARTIES:

The parties shall have experience in running businesses like reputed Hotels, Restaurants and other tourism related activities with minimum annual average turnover of Rs. 5.00 crore and shall be involved in tourism related activities.

PROPOSAL:

1.0 The area approximately 8026 sq.m including an old hospital premises is facing the Baina Beach and close to the proposed elevated four lane road connecting NH17B to Port. The area will be leased out to the eligible party as is where is basis for period of 30 years to be utilized for the construction of hotels, restaurants and any other legally permitted activities to boost tourism in and around Vasco City and also the state of Goa as a whole. This will also benefit the Port user's and persons related to Port activities. The area will be allotted by inviting tenders from parties having experience by following tender cum auction process.

- 2.0 The proposal shall include the following in general:
- (i) A Brief Outline of the company profile which shall cover financial status and experience particulars.
- (ii) The companies' view of the development opportunities.
- (iii) The possible options for implementation, if any alternative proposal can be made based on the past success in similar type venture.
- (iv) Most appropriate model to be structured based on similar ventures elsewhere.
- (v) Time required for developing the facility.
- (vi) Capital expected to be incurred for developing the facility, recurring expenditure and source of funding for the recurring expenditure.
- (vii) Management model of the facilities created.
- (viii) Suggestion on the proposed period of lease of 30 years.
