

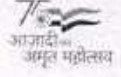

Sub: Change in Rates of Terminal Charges w.e.f. 01.04.2024 onwards.

This is to bring to your kind notice that South Western Railways have notified the Rates of Terminal charges revised by the Railway Board. The revised rate which is to be collected by the Port Trust from the Customers directly for a period of two years w.e.f. 01.04.2024 to 31.03.2026.

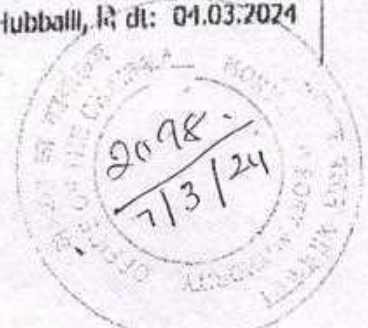

Sub: Rates of Terminal Charges to be collected by Port Trust Railway directly from customers.

Ref: 1. Railway Board's Lr No. TCR/1543/2019/1/3342408 Dt 04.03.2024
(Rates Circular No.06 of 2024)

2. Rates Circular No.03 of 2019 dated 21.02.2019 and its corrigendum No. 01 dated 06.06.2020 followed by Rates Circular No. 08 of 2021 dated 10.03.2021, Rates Circular No. 09 of 2022 dt 31.03.2022 and Rates Circular No. 03. of 2023 dt 21.03.2023

In terms of Rates Circular No. 03 of 2019 and its corrigendum No. 01, the rates for Terminal charges to be collected by different Port Trust Railways for the period from 01.04.2019 to 31.03.2021 were conveyed. The same rates were continued to remain valid till 31.03.2022 in terms of Rates Circular No. 08 of 2021, further up to 31.03.2023 in terms of Rates Circular No. 09 of 2022 and further up to 31.03.2024 in terms of Rates Circular No. 03 of 2023.

Now, Railway Board vide letter No. TCR/1543/2019/1/3342408 Dt 04.03.2024 has communicated that the matter has been examined and it has been decided to charge at the rate of Rs. 30.11 per tonne beyond 31.03.2027 till 31.03.2026 for all types of traffic to be collected by the Port Trust.

The terms and conditions, notified vide Rate Circular No.88 of 2007, in respect of collection and payment of Terminal Charges will continue to apply unchanged.

These charges are distinct from 'Terminal Charges', levied on Railway Goods Sheds and Private Freight Terminals, issued vide Board's letter No. TCR/1078/2018/17 dated 27.12.2018 (Rates Circular No. 24 of 2018).

Therefore, it is requested to collect the revised rate of Terminal Charges directly from customers, as per Railway Board's letter dated 04.03.2024, i.e. Rs.30.11 per tonne for all type of traffic for the period from 01.04.2024 to 31.03.2026.
