## TRADE CIRCULAR NO. 4-12022

- Ref: 1. Trade Circular No. 06/2021 issued under reference TM/289/2021/1563 dated 07.01.2021.
  - Trade Circular No. 02/2021 issued under reference TM/289/2021/914 dated 20.08.2021
  - 3. <u>Trade Circular No. 02/2022 issued under reference TM/289/2022/1750 dated 31.01.2022</u>
    - 1. In continuation of the trade circular referred above, the members of the Trade are hereby informed that it has been decided to accept additional Bank Guarantee in place of Solvency Certificate. Bank Guarantee should be from any nationalized bank payable at any branch in Vasco da Gama, Goa. This is in addition to security deposit as per regulations.
    - Validity of the bank guarantee for all below mentioned licences should be licence period plus additional six months.
    - Alternatively, instead of a Bank Guarantee, license applicant may on his own volition. submit a Demand Draft in favor of FA&CAO, Mormugao Port Authority, which shall be non-interest bearing.
    - 4. Those who have already submitted Solvency Certificate also have to submit fresh Bank Guarantee and upon receipt of Bank Guarantee, the submitted Solvency Certificate will be returned back.
    - The amount of Bank guarantee is listed below:
