#### **TERMS & CONDITIONS**

- 1. **PRICES:** Kindly submit your offer on FOR destination basis indicating clearly the quantum of taxes, freight, other charges etc.whatever applicable. We are not entitled for 'C' or 'D' forms.
- 2. **EXCISE DUTY:** The quantum of excise duty applicable will not be considered for evaluation of the tender wherever the port is eligible for CENVAT credit. The manufacturers/dealers will have to produce the Tax invoice and all other documentary evidence required for availing the CENVAT credit. The manufacturers/dealers should confirm that they can produce all the documentary evidence required by the excise authorities to enable port avail CENVAT credit. In case they are unable to provide the documentary evidence required to avail the CENVAT credit, their offer will be evaluated including the excise duty component.
- 3. **VALIDITY:** Your quotation should be valid for 90 days from the date of opening of the tender.
- 4. **<u>DELIVERY</u>**: The DSC's should be issued within one week after submission of all documents as per your request.
- 5. **PAYMENT:** 100% payment within 30 days of receipt of materials by RTGS. Kindly fill and submit the enclosed form alongwith your offer.
- 6. **LIQUIDATED DAMAGES**: Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, liquidated damages at 1% of the total basic value of the undelivered quantity will be levied per every week or part thereof of delay. The total liquidated damages shall however not exceed 10% of the total basic value of the order. The total basic value here means the total value of the order exclusive of excise duty, taxes etc. The date of dispatch of materials from your works will be considered as date of delivery for the purpose of Liquidated Damages.
- 7. **FORCE MAJEURE:** In case of failure to deliver the goods in time, which shall have arisen due to war, insurrection, restraint imposed by the Govt. Act of legislation or other Authority, accident, strike, riot, lockout or unforeseen events beyond human control directly or indirectly interfering with the supplies of stores or from any cause which the purchaser may admit as reasonable ground for an extension of time, the purchaser will allow such additional time he considers reasonable provided that the contractor shall report to the purchaser the occurrence of any cause as aforesaid which will or might affect the performance of the contract within a reasonable time. Request for extension received after expiry of the delivery schedule will not be entertained. Kindly confirm your acceptance.
