**TRADE NOTICE NO. 04/2022**

**Sub: Increase in Scale of Rates (SoR) towards Vessel Related Charges and Cargo Related Charges w.e.f 1st May 2022 to 30th April 2023-Reg.**

The Board of Trustees, Mormugao Port Trust vide their Resolution number 49 of 10.08.2020 have resolved to fix the HMC rates for dry bulk and break-bulk cargoes at the rate of 15% above Ship crane charges (CHLD) or the HMC rates prior to revision in August 2019, whichever is higher. Accordingly vide TM/02/28/2021/1693 dated 22/01/2021, TRADE NOTICE NO. 02/2021, Rationalized the HMC Charges.

However, the Indian Ports Association (IPA) vide its letter dated 22.03.2022 bearing ref no: IPA/MSD/WPI/Tariff/2022 has directed for indexation of SoR by applying an indexation factor of 10.77% for the year 2022-23, subject to achievement of the performance standards as per clause 2.8.2 and automatic annual indexation of SoR applicable as per clause 2.8.1 of the Tariff Policy for Major Port Authorities, 2021 is 6.46%.

The revised rates applicable for item No. 2.6 Miscellaneous Cargo Related Charges, under 2.6.1. Mobile Harbour Crane rates shall be as given below :
