- PRICES: The bidders should quote FIRM prices and should be on F.O.R. destination basis to be supplied to our stores at MPT Hospital on door delivery basis.
- 2. <u>DELIVERY:</u> The instrument shall be supplied within <u>4-6 weeks</u> from the date of receipt of purchase order.
- 3. The instrument should cover the Guarantee/Warranty period as per the Manufacturer's policy.
- 4. <u>Performance Guarantee/Retension Money:</u> 10% of the invoice value (before GST) will be retained from the bill & the retained amount will be released on completion of a defect liability period.
- 5. **PAYMENT**: Our payment terms will be 100% within 30 days on receipt of materials/bills whichever is later only through EFT.
- 6. <u>LIQUIDATED DAMAGES:</u> In the event of delay in supply, liquidated damages at 1% of the total basic value of the undelivered quantity will be levied per week or part thereof of delay. The total liquidated damages shall however not exceed 10% of the total basic value of purchase Order. The total basic value here means the total value of the Order exclusive of GST, etc. The date of receipt of the item in our Stores will be considered as date of delivery for the purpose of liquidated damages.
- 7. FORCE MAJEURE & EXTENSION IN DELIVERY PERIOD: In case of failure to deliver the material/medicine in time which shall have arisen from war, insurrection, restraint imposed by the Govt., Act or legislation or other authority, accident, strike, riot, lockout or unforeseen events beyond human control directly or indirectly interfering with the supplies of stores or from any cause which the purchaser may admit as reasonable ground for an extension of time, the purchaser will allow such additional time he considers reasonable provided that the contractors/suppliers shall report immediately to the purchaser on the occurrence of any such cause as aforesaid which will or might affect the performance of the contract.
