1. **PRICES:** Kindly quote your prices on F.O.R. destination basis inclusive of transit insurance indicating clearly the quantum of GST for each item along with HSN Code.
2. **DELIVERY:** The material should be supplied to our stores at Baina, within 4 week from the date of receipt of order.
3. **PAYMENT TERM:** Payment (by ECS/RTGS) will be 100% within 30 days of receipt of materials or bills whichever is later.
4. **VALIDITY:** Your offer should be firm and valid for a minimum period of 30 days from date of opening of tender or else your offer will not be considered.
5. **LIQUIDATED DAMAGES:** Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, liquidated damages at 1% of the total basic value of the undelivered quantity will be levied per week or part thereof delay. The total liquidated damages shall however not exceed 10% of the total basic value of the order. The total basic value here means the total value of the order exclusive of excise duty, taxes etc. The date of receipt of materials will be considered as date of delivery for the purpose of Liquidated Damages.
