- 2. Delivery: Should be to our Stores within 4 weeks of date of receipt of order
- 3. Payment: 100% within 30 days of receipt of materials
- 4. Your quotation should be valid for 30 days after opening of tender
- 5) <u>LIQUIDATED DAMAGES</u>: Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, liquidated damages at 1% of the total basic value of the undelivered quantity will be levied per every week or part thereof of delay. The total liquidated damages shall however not exceed 10% of the total basic value of the order.
