- 2. **<u>DELIVERY:</u>** The delivery period is within 2 weeks. You will have to dispatch the material to our store, duly insured, on FOR Destination basis. <u>Confirm acceptance</u>. Kindly quote accordingly.
- 3. **LIQUIDATED DAMAGES**: Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, Liquidated Damages at 0.5% of the total basic value of the <u>undelivered quantity</u> will be levied per week or part thereof of delay. The total Liquidated Damages shall however not exceed 10% of the <u>total basic value of the order</u>. The total value here means the total value of the order exclusive of taxes, freight etc. **The date of receipt of material at our Store at Baina, Vasco**

will be considered as date of delivery for the purpose of Liquidated Damages. Confirm acceptance.
