- 2. <u>DELIVERY</u>: The material should be supplied to our stores at Baina, within 4 week from the date of receipt of order.
- **3. PAYMENT TERM:** Payment (by ECS/RTGS) will be 100% within 30 days of receipt of materials or bills whichever is later.
- **4.** <u>VALIDITY</u>: Your offer should be firm and valid for a minimum period of 30 days from date of opening of tender or else your offer will not be considered.
- 5. <u>LIQUIDATED DAMAGES</u>: Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, liquidated damages at 1% of the total basic value of the undelivered quantity will be levied per week or part thereof delay.
