- 3. <u>LEAFLET:</u> The offer should be accompanied by leaflets or brochures of the fittings offered. Kindly confirm whether the lights offered match all the specifications indicated therein.
- 4. **LIQUIDATED DAMAGES**: Supply schedule as per order should be strictly adhered to.
