- **VALIDITY:** Your quotation should be valid for 60 days from the date of opening. **Confirm acceptance**.
- **<u>LIQUIDATED DAMAGES:</u>** Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, Liquidated Damages at 1% of the total basic value of the undelivered quantity will be levied per week or part thereof of delay. The total Liquidated Damages, shall however, not exceed 10% of the total basic value of the order. The total value here means the total value of the order exclusive of taxes. The date of receipt of material at our Stores at Baina, Vasco will be considered as date of delivery for the purpose of Liquidated Damages. Confirm acceptance.
