TECHNICAL SPECIFICATIONS

1.1. GENERAL

Mormugao Port Trust, Goa, is in process of removing all the wrecks present within the Port limits by e-tendering. Once bidder is finalised, work will be awarded, who in turn will commence removal of wreck. Once Bidder completes removal of each wreck, Port needs to ascertain if any wreck pieces are remaining on or in the seabed, for which Port needs to carry out independent underwater magnetometer survey at existing wreck sites.

1.2. SCOPE OF WORK

The Scope of Work broadly includes:

1. Site Condition.

Wreck Site Sequential order for magnetometer survey for wreck, pieces on SEABED, including pieces fully and partially submerged in SEABED

- 1. WRECK PLATES OF EHRENFELS & BROWNFELS VASCO BAY INNER ANCHORAGE MORMUGAO PORT (1979-80)
- 2. MV MARINER IV, 1998 and f.t. ARATS,1996 f.t.ARIES,1996, f.t. VEGA,1996
- 3. Wreck f.t. MOTHER PEARL, 1997

- 2. The Contractor needs to carry out magnetometer survey at all three wreck sites after removal of wrecks by Port appointed salvage contractor. Dates tentatively will be in the month of March or April 2017 or any subsequent date assigned by the Port.
- **3.** The magnetometer survey is required to certify that no wreck pieces/steel pieces are presenteither on the seabed or embedded in the seabed. For the information of theContractor, the port intends to carry out capital dredging in these areas upto -19.8m
- 4. The Contractor needs to submit budgetary quote for the same. The quote may be submitted in Indian Rupees onlumpsum basis, separately for each area.

- 5. The contractor shall indicate shortest time required for mobilizing equipment so that the port can give sufficient advance notice for mobilizing survey equipment and manpower.
- 6. The offered rates shall be inclusive of all taxes except Service Tax which will be paid as applicable. However, any new tax will be imposed by State/Central Govt. and same will be reimbursed on producing documentary proof.
