COMMERCIAL TERMS AND CONDITIONS

- <u>PRICES:</u> Prices quoted should be as per the Price Bid format. GST will be paid extra as applicable. The prices should be firm for a period of 90 days from the date of opening of the tender. However, in case of any statutory revision in taxes within the validity period of tender, the same will be considered provided you furnish documentary evidence such as copy of Govt. notification.
- 2. <u>AMC PERIOD:</u> The duration of the contract will be ONE Year i.e. from 01.12.2021 to 30.11.2022 and the same may be extended upon satisfactory completion of one year service for further period of One year with mutual consent at existing rate and terms & conditions.

- 8. <u>LABOUR:</u> The Contractor shall at all times during the continuance of the Contract comply fully with all existing Acts, Regulations and bye law as including all statutory amendments and reenactment of the Central Government and other local authorities and any other enactment and acts that may be passed in future either by the Central Government or local authority, including Indian Workmen's Compensation Act, Labour Laws and Equal Remuneration Act, 1976, Factories Act, Minimum Wages Act, IE Act 1956, etc.

- 9. <u>AGREEMENT:</u> On receipt of award of work, Security Deposit to be furnished and an Agreement shall be executed on stamp paper of Rs.1000/- between the BOARD and the successful Bidder within 30 days of the award of the contract or in default and until, a formal agreement is prepared and executed, this tender together with written acceptance thereof shall constitute a binding contract.

- 13. COMPENSATION FOR DELAY IN EXECUTION OF CONTRACT: If the Bidder fails to commence the work in all respects within the time specified or within the extended time that may be allowed by the Port, the Bidder shall pay to the Port a sum equivalent to 0.5% per week or part thereof of the total value of the contract subject to a maximum of 5% of the total value of contract as liquidated and ascertained damages and not by way of penalty which may also be deducted from any moneys due to the Bidder. 1.0 FINANCIAL ELIGIBILITY:

- 1.1 Bidder's experience of having successfully completed the work of Annual Maintenance Contract comprising of Support/Maintenance of Windows Servers 2012/2016, Thin Clients, VMware etc. during the last three years from the due date of submission of bid. The Work Order as well as completion date should be within last 3 years from the due date of submission of bid. Copy of the Purchase/Work Order along with corresponding completion certificate from the client should be furnished. The completed works should be either of the following: -
 - 1.1.1 Three similar completed works of not less than Rs. 1,24,800/- OR
 - 1.1.2 Two similar completed works of not less than Rs. 1,87,200/- each OR
 - 1.1.3 One similar completed works of not less than Rs. 2,49,600/- each
- 1.2 Similar Works means "Support / Maintenance of Windows based Servers, Thin Clients, VMware, etc."
- 1.3 Bidder shall enclose the copies of work orders for similar works, successful completion certificates with performance from clients indicating the date of completion, value of work done etc
- 1.4 Bidder should have his Branch Office/Service Centre in Goa for local support/repairs if required.

- 1.8 "Bidder" (including the term 'tenderer', 'consultant' or service provider in certain context) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the description of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.
- 1.9 "Bidder from a country which shares a land border with India" for the purpose of this order means:
 - a. An subsidiary incorporated, established or registered in such a country; or
 - b. A subsidiary of an entity incorporated, established or registered in such a country; or
 - c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
 - d. An entity whose beneficial owner is situated in such a country; or
 - e. An Indian (or other) agent of such an entity; or
 - f. A natural person who is a citizen of such a country; or
 - g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above
- 1.10 The *beneficial owner* for the purpose of para 1.8 above will be as under:
 - In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

Explanation—

- a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of the shares or capital or profits of the company;
- b. "Control" shall include the right to appoint majority of the directions or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
- 2. In case of partnership firm, the beneficial owner is natural person(s) who, whether acting alone or together, or through one or more judicial person, has ownership of entitlement to more than fifteen percent of capital or profit of the partnership;

- 3. 2.0 SCOPE OF WORK

- **2.8.** The Engineer should have his own two-wheeler vehicle to promptly attend to calls in Port areas.
