TECHNICAL SPECIFICATION

1.0. **GENERAL**

Mormugao Port Trust invites Tender in single cover system for the work of "<u>Providing of Power supply points for portable Mist Cannon at B. No 10/11 areas and excavation of trench of 12 meters in length for rectification of damaged power supply cable of High Mast No. 32"</u>

2.0. SCOPE OF WORK

The Scope of work involves:

- 1. Clamping of 4 core x 25 sq.mm Aluminum armoured cable on wall with GI clamps at 1 meter spacing. (Cable will be supplied by Port). Total length of cable in the wall is 120 meters.
- 2. Laying of 23 meters cable in excavated trench of size 0.4m wide and 0.8 m deep through GI pipe 3" dia. at road crossing. (GI pipe "B" class will be supplied by Port).
- 3. Laying of 5 meters cable on T-2 shed ramp through 3" dia. GI pipe with cementing on top (GI pipe "B" class to be supplied by Port).
- 4. Excavation of cable trench of length 35 meters of size 0.4mx0.8m deep in asphalted road and back filling at locations indicated by site engineer.
- 5. Supply, Installation and wiring of Distribution box mounted on MS angle stand 3 feet height, well grouted, containing 1 No.4 pole, 32 Amps MCB, 1 No. 32 Amps 5-pin wall mounted type IP44, Industrial socket and provision of 1 no. 15 Amps switch socket point inside DB. (DB should be grey painted and outdoor type with provision of glands for 4core, 25 sq.mm cable). Termination of 4 core X 25 sqmm cable in DB. Testing and commissioning.
- 6. The locations of power point and excavation will be as indicated by the site Engineer.

3.0. GENERAL TERMS AND CONDITIONS

- **3.1.** The Contractor shall commence and complete the work as per the BOQ and proper safety precautions should be taken at the electrically charged installation at the substation. The work is to be carried out as per the site conditions and relevant IS standards.
- **3.2.** Work should be carried out to the satisfaction of the Engineer in charge. All left over/scrap materials, debris etc. are to be promptly cleared and remaining Port material like cable etc. have to be shifted from the work site to electrical workshop to MM Depot by the Bidder at his own cost and risk as per the directions of Engineer In Charge.

4.1. Eligibility of the Tenderer

The following should accompany the bid document in sealed cover, viz.

- i) The contractor should be experienced Electrical contractor having who has executed similar works in the past. A copy of completion certificate for having executed similar works shall be furnished along with the bid which shall be verified before award of LOA/P.O.
 - Similar works implies "laying of cables in any Govt. or reputed Private organisation".
 - ii) Tender document issued by the Port shall be duly initialled on each page with rubber stamp of the Bidder and submitted along with the bid.
 - iii) Certificate of Registration with PF Commissioner/ESI authorities and GST.

- iv) Price Bid should be duly filled in. Bidders are advised to quote strictly as per the price bid.
- v) Appendix I, II, and III should be submitted duly filled in.

4.2. Validity:

The validity period of the offer shall be 60 days from the date of opening of the bid.

4.3. **Price**:

- The bidder shall quote the price exclusive of GST. Applicable GST shall be paid on the quoted price. The bidder shall indicate the applicable GST rate on the goods/services in the price bid.
- ii) Evaluation will be done considering only the basic price.

4.4. Bid Security Declaration (BSD)

Bidder should arrange for the Bid Security declaration as enclosed at **APPENDIX-III**. The original BSD should be enclosed along with tender while submitting commercial bid. The BIDDER shall submit the Bid Security Declaration Format in lieu of EMD. The tender not accompanied with Bid security declaration shall be summarily rejected.

4.5. Completion Period:

The entire work shall be completed within **45 days** from the 7th date of receipt of LOA/purchase order, whichever is earlier.

4.6. Payment Terms:

- 100% payment shall be made within 15 days after satisfactory completion and upon successful commissioning of the work on furnishing undisputed invoice complete in all respects.
- ii) The contractor shall furnish their bank account details for the payment through ECS by the Trust. A copy of the PAN card, GST code, wage register, attendance register, EPF& ESI, Bank account number, MICR number, Name of the Branch along with Bills shall be furnished for arranging payment made through E.C.S. by the Trust.
- **iii)** The bidder shall quote GST No. of MPT (30AAALM0293P1ZY) on all invoices raised on Port. If bidder is not registered under GST or opted for composition scheme under GST, undertaking of the same shall be submitted by the bidder.

4.7. Liquidated Damages:

In the event of failure by the contractor to complete the execution of the work within the time stipulated in the contract or by the expiry of any period of extension granted by the Board's terms thereof, the contractor shall pay the Board as Liquidated Damages for delay to complete the work, a sum of 0.5% of contract price per week or part thereof subject to a maximum of 5% and the Board shall have the power to deduct this amount from the payment of the amounts due to the contractor or from his deposit. The GST @ 18% on LD will be deducted at the time of making payment to Vendors/ Contractors.

4.8. Other terms and conditions

i. All tools and tackles and logistics involved in the work shall be arranged by the Contractor at their own cost. The transportation cost, if any, shall be borne by the contractor.

- ii. The Bidders are advised to visit the site and get acquainted with the quantum of the work involved and site conditions before quoting for the works.
- iii. The scope of work and bill of quantities at "**ANNEXURE-I**" to be read in conjunction to ensure the actual supply of materials and works involved.
- iv. Necessary Entry passes shall be obtained by the Contractor at their own cost with prior approval of the Port Officials on Duty.
- v. The Trust will not be responsible for any loss or damage to the materials/ tools/plants engaged by the contractor/bidder during the work at site or transportation.
- vi. The Contractor shall take utmost care during the execution of the work, if any damage caused to the Port property, the cost of the damage shall be recovered from the Contractor's running A/c bill or may be recovered by the Board in any other mode as deemed fit.
- vii. The power supply shall be provided by the Port free of cost for execution of the work; however, the Contractor shall take power supply from the nearest source by making suitable arrangements at their own cost and risk.
- viii. Any work not mentioned herein above but necessary for overall completion of the work shall be deemed to be included in the scope of work without any additional financial implications to the Port, whatsoever.
- ix. Under any circumstances, if the work is abandoned by the contractor for whatever reasons, the same shall be executed for successful commissioning 'thro' the external agency to be engaged by the Port at the risk and cost of the contractor. The expenditure incurred by the Port in this regard shall be recovered from the monies due to the contractor / security deposit or as deemed fit by the Board.
- x. The works shall be carried out with due regard to safety standards prevailing in the Port.
- xi. All the workmen shall be covered under a suitable insurance policy. Accidents, if any, fatal or otherwise at site shall be the sole responsibility of the contractor. The Port should not be held liable for compensation in whatsoever manner under any circumstances.
