1.0 SCOPE OF WORK:

Supply of VHF Radio and Amendment on the Operating License

- Collect necessary documents from the MPT, and obtain permission from Wireless Planning & Coordination Wing (WPC), Department of Telecommunication, New Delhi for replacement of 20 nos VHF Radio provided under existing wireless operating Licenses (WOL).
- 2. Cancelation of unwanted wireless operating Licenses from WPC.
- 3. Destruction of old VHF Radio and issuing destruction Certificate for the same.
- 4. Supply of VHF Radios as per Annexure-I.
- 5. Program and install the VHF Radio as per the frequency and Channel provided by the MPT/ WPC.
- Checking the communication at different location in the port area (with & without VHF Repeater).
- 7. All the sets shall be tested for proper performance in presence of the Engineer in Charge and a report shall be prepared, duly signed and submitted to the Port.
- 8. Collect necessary documents from the MPT and obtain the amendment on the existing WOL license from the WPC.

2.0 Terms and conditions:

- Contractor should have valid Dealer Possession License (DPL) and copy of the same should be submitted along with tender documents.
- 2. The bidder should have local support office in Goa for both hardware & software support and have trained staff on their rolls directly. In case of any failure on the supplied sets during the Guarantee period, the same should be attended immediately. Enclose the local office detail along with the tender document.
- Contractor has to collect all the necessary documents required for replacement of VHF
 Radio and amendment on the existing wireless operating Licenses and apply through
 online / offline as per WPC guideline.
- 4. The Contractor shall give the Guaranty of all the equipment for a period of **24 months**.
- 5. Breakdown must be attended within 24 hrs.
- Incase equipment requires repairs outside Port premises then contractor has to take all responsibility for transportation, charges shall be borne by the Contractor itself and handover the equipment within 15 days.
- 7. No additional cost will be borne by the Port for Destruction of old VHF sets and Issue Destruction Certificate.
- 8. No additional cost will be borne by the Port for cancellation of unwanted licenses from WPC.

- 9. Port will bear the License fees / modification fees / royalty charges as per stipulated rates given by the WPC.
- 10. Work must be completed within 180 days including Amendment of existing Operating License.
- 11. If any delay occurs due to WPC clearance, contractor has to produce written evidence of the same.

3.0 Validity:

The validity period of the offer shall be 60 days from the date of opening of the bid document.

4.0 Price:

- i) The bidder shall quote the price exclusive of GST. Applicable GST shall be paid on the quoted price. The bidder shall indicate the applicable GST rate on the goods / services in the price bid.
- ii) Evaluation will be done considering only the basic price.

5.0 Bid Security Declaration:

i) The Bidder shall furnish as part of its bid document, "Bid Security Declaration" as per the given format. If Contractor withdraw or modify their bids during period of validity etc., they will be suspended for the time specified by the Port.

6.0 Security Deposit:

The contractor shall furnish the Security Deposit through e-payment mode, within 15 days from the date of issue of Letter of Acceptance (LOA) / Purchase Order (P.O) whichever is earlier. The Security Deposit shall be converted to Performance Guarantee during the guarantee period of 24 months.

- a) The 03% of the contract value rounded off to nearest 100 rupees shall be submitted within 15 days of issue of Letter of Acceptance / Purchase Order whichever is earlier. Same will be returned after successful completion of Guarantee period of Two year (24 months).
 - ii) Forfeiture of SD: The security deposit will be forfeited, if the contractor fails to fulfil any or all the conditions of this contract, without any interference from it towards all rights of the Board to recover from the contractor any other amounts falling due to the Board through non-observance/compliance by the contract conditions and any of the clause thereof by the contractor.

7.0 RATES AND AMOUNTS INCLUDE ALL CHARGES

The rates and amounts submitted by the Bidder shall include all payments on account of taxes, levies, duties, royalties, etc., payable to the State of Goa or Government of India or any other authority or Body Corporate and all other incidental charges that the Bidder may have to bear for the execution of the Works. The Bidders shall make their own arrangements to ascertain the applicable rates in respect of Central Excise Duty from the concerned Govt. Authorities. However, GST will be extra as applicable.

8.0 Guarantee Period:

The Contractor shall give the guarantee for a period of **24 months** from the date of taking over of the work. Any defect observed during the guarantee period, the same shall be set right by the Contractor, free of cost without any financial implications to the Port, whatsoever.

9.0 Payment Terms:

- i) 70% of payment (on pro-rata bases) shall be released against supply, installation, testing and commissioning of the VHF Radios.
- iii) Balance 30% of the payment (on pro-rata bases) will be released on receipt of amended wireless operation Licenses and completing the work in all respect.

The contractor shall submit all the relevant documents along with the invoice.

- i) Payment shall be released within **15 days** upon furnishing undisputed invoice complete in all respects. Payment shall be made as per actual.
- ii) The contractor shall furnish their bank account details for the payment through ECS by the Trust. A copy of the PAN card, GST code, wage register, attendance register, EPF& ESI, Bank account number, MICR number, Name of the Branch along with Bills shall be furnished for arranging payment made through E.C.S. by the Trust.
- **iii)** The bidder shall quote GST No. of MPT (30AAALM0293P1ZY) on all invoices raised on Port. If bidder is not registered under GST or opted for composition scheme under GST, undertaking of the same shall be submitted by the bidder.

10.0 Liquidated Damages:

In the event of failure by the contractor to complete the execution of the work within the time stipulated in the contract or by the expiry of any period of extension granted by the Board's terms thereof, the contractor shall pay the Board as Liquidated Damages for delay to complete the work, a sum of 1% per week or part thereof of the total contract price subject to a maximum of 10% of the total contract price and the Board shall have the power to deduct this amount from the payment of the amounts due to the contractor or from his deposit. The GST @18% on LD will be deducted at the time of making payment to Vendors/Contractors.

11.0 Other terms and conditions

- i) All tools and tackles and logistics involved in the work shall be arranged by the Contractor at their own cost. The transportation cost, if any, shall be borne by the contractor.
- **ii)** The Bidders are advised to visit the site and get acquainted with the quantum of the work involved and site conditions before quoting for the works.
- **iii)** The scope of work and bill of quantities at "**ANNEXURE-1**" to be read in conjunction to ensure the actual supply and works involved.
- **iv)** Necessary Entry passes shall be obtained by the Contractor at their own cost with prior approval of the Port Officials on Duty.
- v) The Trust will not be responsible for any loss or damage to the materials/ tools/plants engaged by the contractor/bidder during the work at site or transportation.
- vi) The Contractor shall take utmost care during the execution of the work, if any damage caused to the Port property, the cost of the damage shall be recovered from the Contractor's running A/c bill or may be recovered by the Board as deemed fit.

- vii) The power supply shall be provided by the Port free of cost for execution of the work; however, the Contractor shall take power supply from the nearest source by making suitable arrangements at their own cost and risk.
- viii) Any work not mentioned herein above but necessary for overall completion of the work shall be deemed to be included in the scope of work without any additional financial implications to the Port, whatsoever.
- Under any circumstances, if the work is abandoned by the contractor for whatever reasons, the same shall be executed for successful commissioning 'thro' the external agency to be engaged by the Port at the risk and cost of the contractor. The expenditure incurred by the Port in this regards shall be recovered from the monies due to the contractor / security deposit or as deemed fit by the Board.
- **x)** The works shall be carried out with due regard to safety standards prevailing in the Port.
- **xi)** All the workmen shall be covered under a suitable insurance policy. Accidents, if any, fatal or otherwise at site shall be the sole responsibility of the contractor. The Port should not be held liable for compensation in whatsoever manner under any circumstances.
