1. Quantities put up for disposal on weight basis are only projected quantities. It may be plus or minus 10%. The excess quantity available at the time of delivery will have to be lifted by the bidder on payment towards excess quantity.

Items put up for disposal are on "as is where is basis and no complaint basis". Materials is to be lifted as per the instructions of our representative.

- **2. (i) IMPORTANT NOTE**: The bidders participating in item at **Sr. No. 06, 07, 08, 09 & 25** should be registered with the MOEF/CPCB Ministry of Environment and Forests/ Central Pollution Control Board as recyclers/pre-processors having environmentally sound management facilities. They should produce a valid certified copy of the certificates of registration, failing which they should not be allowed to participate for this item. The delivery period for lifting of material is 30 days.
- (ii)NB: Please note that TCS is not applicable on sale of scrap of Mormugao Port Trust. Hence you are requested not to levy TCS at the time of issue of sale acceptance letter/delivery order to the highest bidder.
- (iii) Item at sr. no. 26, 27 & 28 only material inside the container will be sold (i.e. exclusive of container)
- (iii) Item at sr. no.16 to be shredded compulsory by the bidder before taking delivery.

3. ADDITIONAL TERMS & CONDITION FOR SR. NO. 07

INFORMATION & GUIDELINES FOR AFFF DISPOSAL WORK FOR THE HIGHEST BIDDER

- 1) Presently Aqueous Film Forming Foam (AFFF) of quantity around 17000 ltrs. is stored in 2 Nos. Fibre Glass Tanks of 10 KL capacity each.
- 2) Each Tank, of dimension 2000mmx6880mm, is having individual shut off Valve fitted at Discharge side. The quantity of AFFF is mentioned is approximate, however actual disposal quantity may vary and can be ascertained by inspecting site.
- 3) The discharge line for disposal of foam is about 2" dia. which is at Pump House of Tower Monitor Building at 0.5 mtr. below the road level.
- 4) The Disposal party / H1 bidder will have to follow the following guidelines:

- a) The Disposal action will be carried out only when no POL vessel is at berth No. 8 and same is to be carried out during daytime only.
- b) At first AFFF from 1 tank ie. approximately 8500 ltrs. is to be taken out. The other tank will be isolated during that time. After draining from 1st tank, the tank has to be flushed with water and has to be drained once again for removing any residues. The water for the same will be arranged by Port.
- c) After removal of all AFFF from 1st tank, Port will take action for refilling new foam in this tank.
- d) After completion of refilling of foam in 1st Tank Port will inform party to take action for removing foam from 2nd Tank, which also has to be carried out when no POL vessel is at Berth No. 8 and during daytime only. After draining from 2nd tank, the tank has to be flushed with water and has to be drained once again for removing any residues. The water for the same will be arranged by Port.
- e) Party shall arrange their own drum/Barrel or a tanker having sufficient quantity to store/transport the foam. The necessary in & out gate pass for men and material will be issued by MM department.
- f) Party shall take all the necessary safety precautions while removing, storing, transporting, disposing of the subject AFFF as per the standard environmental guidelines with regard to disposal of the same.
- g) Foam tanks are fitted on 2nd Floor of Fire Fighting building and for disposal purpose gravity flow system is to be used.

4. General Terms & Conditions

- (1) Items put up for disposal are on as is where is basis and no complaint basis. Materials is to be lifted as per the instructions of our representative. It is the responsibility of bidders to inspect the material before bidding in the e-Auction.
- (2) All safety and labour laws have to be followed. Permissions if any should be obtained before Material is to be lifted as per the instruction of MPT representative by providing contractors own manpower & equipments.
- (3) The area is Custom Bound. Permission of the Customs Office has to be obtained to remove the material from the gate if required. However, Port shall assist by issuing necessary letters.
- (4) The highest bidder will have to pay all the Taxes and duties applicable before lifting of the material. The entire work shall be completed by the highest bidder after full payment of material within 30 days from the date of issue of Delivery Order.
- (5) The Contractor shall follow all safety norms throughout the period of work. Provisions of Bureau of Indian Safety Standards and other sound engineering practices shall be followed for the same.

- (6) The Contractor shall take all the precautions for rain, storm etc. and no liability shall rest with the Chief Mechanical Engineer for any loss of plant, machinery, labour or in cases of cost involved due to re-erection, rectification, remobilization, or retrieval of lost machinery etc. due to any unforseen factors.
- (7) Damages Any existing services or other properties if damaged or demolished during the course of execution either wilfully or negligently, shall be repaired or re-erected by the Contractor. The Contractor will take all precautions against damages due to rain and storm and no liability shall rest with the Chief Mechanical Engineer/ Mormugao Port Trust for any loss for redoing of any work due to this account. Existing Port services coming in the way of execution of this work etc. have to be adequately considered and supported by the Contractor at his own cost so as to avoid any obstruction or delay into delivering the contractual services.
- (8) In case of any accidental damage caused by the Contractor to the Port assets, the contractor shall arrange to rectify and reinstall those services immediately. Alternately, the Port shall undertake such repairs and recover the entire costs from the contractor, and the contractor shall not object to the same.
- (9) The contractor shall arrange at his own risk and cost towards security services for the man and equipments deployed at work site.

Liquidated Damages: In the event of failure by the highest bidder to remove/clear scrap materials within the time stipulated in the delivery order or by expiry of any period of extension granted by the Authority, the bidder shall pay Liquidated damages for delay to complete the work a sum of 0.5% per week or part thereof subject to maximum of 5% of the total quoted price.

By bidding in the e-auction, it is construed that the successful bidder(s) have fully understood the Special terms and conditions of the e-auction read along with the GTC & BSTC and agreed the same in toto.

Seller reserves the right to accept or reject any or all offers without assigning any reasons whatsoever.

CAUTION :

1) The Bidder shall be solely responsible for all consequences arising out of the bid submitted by him (including any wrongful bidding by him) and no complaint / representation will be entertained by MSTC/Principal in this regard. Hence Bidders must be careful to check (the Bid Amount/No. Of '0'/No. Of Digits/Unit Of Measurement etc.) and rectify their bid (if required) before submitting their Bid into the live e auction floor by clicking the 'Bid' Button. - 8.0) Rate must be quoted exclusive of applicable taxes and duties which will be charged as on date of delivery. Any variation in such taxes and duties will be borne by the buyers.
- 9.0) The Bidders/customers workmen shall have to abide by the rules regulation including safety & security regulation of the relevant statutory Acts. Entry inside the works should only be against Gate pass for the men and equipment for which purchaser will have to apply well in advance before lifting commences.
- 10.0) The Buyer will employ his own labor and means; at his own cost and risk for removal/collection/shifting of scrap as per schedules and payment of wages/compensation to the labourers will be the sole responsibility of the buyer. The purchaser shall ensure that his workmen do not loiter around within the stores area of the factory areas. They shall not touch any material except those material shown to them. If any of his workmen is even found violating these restriction, the purchaser shall be responsible for making good the loss to the owners on which their decision shall be final and binding.
- 11.0) **PAYMENT PERIOD:** In case of confirmed Lots, payment for full material value plus all duties & taxes have to be made within 22 days from the date of acceptance of lot. Failure to deposit balance sale value (after depositing post bid EMD as stated in Clause 5 above)

shall lead to forfeiture of EMD deposited by the buyer.

- 11.1) If payment against basic cost only is deposited and amount of GST and Late Payment Fee, if any, etc. is not deposited by buyer then the seller/stockholder at its own discretion shall issue relevant site delivery order for reduced quantities after adjusting the Sales Tax/ Late payment charges etc.
- 11.2) For delayed payment of balance sale value along with taxes and duties, late payment charge @ 1% per week or part thereof for a maximum period of 14 calendar days has also to be charged which should also feature in the STC. However, this shall not confer any right to the Bidder to make any Late Payment of Balance Sale Value or applicable Duties and Taxes MSTC/Seller reserves the right not to accept the payment of the Balance Sale Value with or without the additional charges after the expiry of the due payment time as mentioned above
- 12.0) **DELIVERY PERIOD:** The highest bidders will have to pay all the Taxes and duties applicable before lifting of the material. The entire work shall be completed by the highest bidder after full payment of material within 30 (Thirty) days from date of issue of delivery order. (including date of issue)/or as stipulated by MSTC LIMITED.
- 12.1) In case of delayed lifting, the collection of Liquidated damages in advance shall be the sole responsibility of the seller before effective delivery. The rate of Liquidated damages for delay to complete the work a sum of 0.5% per week or part thereof subject to maximum of 5% of the total quoted price.
- 12.2) In case of Goods sold on Lot Basis, the Liquidated damages will be calculated at the rate specified above on the value of the entire Lot even if lifted in part, where as in case of Goods sold on Unit Weight or Unit Number Basis, the Liquidated damages will be calculated on the value of unlifted quantity However it must be noted by the Bidders that it will be the sole discretion of the Seller not to allow the Buyer to lift the Goods with or without the Liquidated damages after the expiry of the stipulated free Delivery period or even within the aforesaid additional period and in such event, the sale of the material not lifted by the Buyer(s) will be automatically cancelled and all the moneys paid by the Bidder /Buyer will be automatically forfeited.
- 13.0) MSTC/SELLER reserves the right to withdraw in part or full or to close the contract any time during the currency of contract without assigning any reason thereof. This will not entitle the buyer to demand compensation or right for delivery of full quantity by way of extension of contract.
- 14.0) After the submission of bid(s) by the Buyer, a presumption would be drawn that the buyer has inspected the material and has satisfied himself about the nature, quantity ,quality, other technical specifications, taxes-duties and legalities prior to the e-auction. No complaint, whatsoever, on the points referred above, would be entertained after the submission of the bid.

15.0) SALE OF VEHICLES:

15.1) In case of disposal of Old / Used Vehicles, the following procedure will be normally followed:

- (a) For RTO Registered Vehicles sold with RC Book (if available with the PRINCIPAL) the sale will be deemed to be for 'Re-use' and Sale Tax will be charged accordingly. All charges for change to ownership shall be borne by the Buyer. In case the RC Book is not available or lost, necessary Certificate in this regard will be issued by the PRINCIPAL to the concerned RTO with copy to the Buyer to enable them to get the ownership transferred.
- (b) In case of RTO Registered Vehicles sold as Scrap without RC Book, the sale will be deemed as sale of Scrap and GST will be charged accordingly and a Remark will be put on the Delivery Order stipulating that 'Sale is for Scrapping & without RTO Documents'.

However in all the above cases, the PRINCIPAL will have the sole discretion to decide whether they would sell the Vehicle for Scrapping or otherwise and no complaint / representation will be entertained from the Bidder in this regard.

16.0) SALE OF HAZARDOUS WASTE ITEMS:

- 16.1) The sale of Hazardous Waste items, namely Waste Oil and specified categories of Non-Ferrous Metal Waste will be governed by Hazardous Wastes (Management & Handling) Rules, 1989 and its Amendments and the sale of Batteries will be governed by the Batteries (Management & Handling) Rules, 2001 and its Amendments. For such items, only those Parties shall be eligible to bid who have Valid Registration Certificates from the State as well as Central Pollution Control Board (PCB) on the Starting Date of e-Auction. If the Bidder had the said State PCB and /or CPCB Certificate(s) which expired within 30 (thirty) days before the date of starting of e-Auction, he should submit a copy of the expired Certificate(s) and a copy of his Application for extension with a proof of submission of the Application at least one working day before the starting date of e-Auction (within 3 PM).
- 16.2) The Parties eligible for purchase of Hazardous Waste shall be allowed access on the live eAuction floor for participating in the bidding only after they have registered themselves online on the eAuction Website of MSTC by selecting the relevant items of Hazardous Waste on the Supplementary Registration Form hyperlinked to the Buyer Registration Form. Bidders for HW Items are also required to get the validity period of their CPCB Certificate recorded on the Website in their Buyer Registration Form through MSTC and then only their Password will be activated for allowing him to Bid for HW Item. There is no provision in the Website for recording the validity period of Buyers SPCB Certificate. If the validity of Bidder's CPCB Certificate has expired on the Starting Date of eAuction, then there is likelihood of his Password being deactivated, hence the Bidder must ensure to produce valid CPCB Certificate or proof of Application to CPCB for extension to MSTC as mentioned above to get his Password duly activated before the Starting Date of eAuction.

- 16.3) Wherever the Bidder has been allowed to participate in the eAuction on the basis of submission of said proof of Application for extension of his SPCB/CPCB Certificate, he must submit copy of the Valid SPCB/CPCB Certificate(s) along with and within the stipulated time of payment of Balance Sale Value failing which his Bid will be treated as invalid.
- 16.4) In all cases, however, it will be the Bidder's responsibility to ensure that his SPCB and CPCB Certificates are kept valid at the time of taking delivery of materials and till the materials are processed by him. Participation by any Bidder in the e-Auction will be deemed to imply that he undertakes to comply with all his statutory responsibilities as envisaged under the said Rules including keeping their CPCB & SPCB Certificate(s) valid till the material is processed by them. Bidders are particularly advised to see clause No. 20 of the Hazardous Wastes (Management & Handling) Amendment Rules, 2003.
- 16.5) At the time of taking delivery, the Buyer shall fill-up and submit Manifest in Form 9 to the Principal as may be directed by the Principal and he shall also submit copies of the Manifest in Form 9 to the concerned State PCB / Statutory Authorities as per Rule 7(4) & 7(5) of the aforesaid Rules. The Buyer shall also have to produce the Original State / Central PCB Certificates to the Principal at the time of delivery for verification & for necessary endorsement thereon by the Principal as required under the HW(M&H) Rules.
- 16.6) In case of Sale of Waste Oil & specified Non-Ferrous Metal Waste involving transport of such material to the Buyer's Plant / Processing Unit located in a State other than from where such items are being sold, the Buyer must obtain and submit 'No Objection Certificate' from the State PCB where the Buyer's Plant / Processing Unit is located, to the Principal before taking delivery, failing which the sale will be treated as cancelled and further action will be taken by MSTC / Principal as may be deemed fit by MSTC / Principal.
- 16.7) In case of Items other than Waste Oil, specified Catagories of Non-Ferrous Metal Wastes and Batteries, which fall under the category of HAZARDOUS WASTE, the sale will be governed by the Hazardous Waste (M&H) Rules, 1989and its Amendments.
- 17.0) The Bidder(s) shall have no right to issue any addendum to these Special Terms and Conditions or Buyer Specific Terms and Conditions to clarify, amend, supplement or delete any of the conditions, clauses or items stated therein.
- 18.0) The seller and/or MSTC reserve the right to black-list, debar any bidder/buyer due to any act of omission or commission or fraudulent acts indulged or caused to be indulged by such bidder/buyer in the course of bidding process and/or in the execution or performance of any of the contracts which

may be awarded to the bidder/buyer pursuant to the e-auction, provided however, that the Seller and/or MSTC shall be obliged to allow an opportunity of being heard to such bidder/buyer before any order of black-listing/debarment could be passed. Any such order of black listing/debarment that may be passed by the Seller and/or MSTC shall be without prejudice to other right of actions available to the seller and/or MSTC against the bidder/buyer under the e-auction terms and conditions.

19.0) ARBITRATION/ LEGAL JURISDICTION: In the event of any dispute or difference between the parties hereto relating to the interpretation, construction, fulfilment or otherwise of the Agreement, such disputes or differences shall be settled by the process of Arbitration by a Sole Arbitrator to be appointed mutually by the parties to this Agreement. However, in case parties fail to appoint the Sole Arbitrator within thirty days of the invocation of the arbitration by any party, the same shall be appointed as per the provisions of the Arbitration & Conciliation Act, 1996. The venue of such Arbitral proceedings shall be Mumbai. The provisions of the Arbitration and Conciliation Act, 1996 and the Rules framed there under or any statutory modification thereof shall apply to such arbitral proceeding. The language of the Arbitral proceeding shall be English and the costs of Arbitration shall be borne equally by the parties hereto. The Award of the Sole Arbitrator shall be final and binding upon the parties.
