2. **DELIVERY:** The material shall be supplied within 4 weeks of date of receipt of purchase order. The material shall be supplied to our Stores Depot at MPT Hospital, Headland Sada, Mormugao, Goa.
3. **PAYMENT:** Payments will be 100% within 30 days on receipt of materials/bills whichever is later only through EFT.
4. **LIQUIDATED DAMAGES:** In the event of delay in supply, liquidated damages at 1% of the total basic value of the undelivered quantity will be levied per week or part thereof of delay. The total liquidated damages shall however not 10% of the total basic value of each purchase Order exceeds. The total basic value here means the total value of the Order exclusive of GST, etc. The date of receipt of medicine in our Stores will be considered as date of delivery for the purpose of liquidated damages.
