

TENDER TERMS AND CONDITIONS

1. The dealers / distributors / stockiest of Manufacturing Company who quote should furnish the authorization letter from their principal manufacturing company for quoted machine to Mormugao Port Trust Hospital against particular tender.
2. **PRICES :** The prices should be quoted on F.O.R. destination basis to be supplied to our stores at MPT Hospital on door delivery basis. The rate quoted shall remain firm till the supply & installation of the item.
3. Offers should not contain any sort of conditional discounts based on quantity or value of order. Offers containing such conditional discounts will be rejected.
4. **DELIVERY:** The machine shall be supplied, installed & commissioned **within 06 weeks** of date of receipt of order. The material shall be supplied to our Stores Depot at MPT Hospital, Headland Sada, Mormugao, Goa. The delay beyond **06 weeks** from the date of issue of order will be liable for Liquidated Damages (L.D.)
5. **PAYMENT:** Our payment terms will be 100% within 30 days of commissioning of machine/ receipt of bills whichever is later only through EFT.
6. **LIQUIDATED DAMAGES:** In the event of delay in supply, liquidated damages at 0.5% of the total basic value of the undelivered quantity will be levied per week or part thereof of delay. The total liquidated damages shall however not exceed 10% of the total basic value of purchase Order. The total basic value here means the total value of the Order exclusive of GST, etc. The date of receipt of the item in our Stores will be considered as date of delivery for the purpose of liquidated damages.
7. **FORCE MAJEURE & EXTENSION IN DELIVERY PERIOD:** In case of failure to deliver the material in time which shall have arisen from war, insurrection, restraint imposed by the Govt., Act or legislation or other authority, accident, strike, riot, lockout or unforeseen events beyond human control directly or indirectly interfering with the supplies of stores or from any cause which the purchaser may admit as reasonable ground for an extension of time, the purchaser will allow such additional time he considers reasonable provided that the contractors/suppliers shall report immediately to the purchaser on the occurrence of any such cause as aforesaid which will or might affect the performance of the contract. Request for extension received after expiry of the delivery schedule will not be entertained.
8. **PERFORMANCE GUARANTEE:** The successful bidder will be required to effect a deposit of an amount equal to 10% of the basic value (excluding Tax) of the accepted tender as Performance Guarantee for 18 months from the date of despatch or 12 months from the date of installation whichever is earlier. The same may be furnished by Demand Draft or through NEFT/RTGS.
9. **TRANSPORTATION:** - The materials shall be dispatched by suitable transport, duly packed and insured at suppliers' cost, through any reliable Transport Co. The materials shall be dispatched and consigned to the Chief Medical Officer, Mormugao Port Trust Hospital, Headland, Sada, Mormugao, Goa on "freight paid/door delivery " basis.
10. **PACKING:** The materials shall be suitably packed to withstand the hazards of transportations.
11. The Bidder should furnish in Goa. an Order Copy, relavant Tax Invoice & Completion report for having supplied similar Phototherapy Unit during last five years to any reputed Hospital
12. Kindly confirm the Guarantee/Warranty period & Number of free services that will be provided during warranty/guarantee period clearly in your offer.

13. Party should have its service centre in and around Goa and should be able to attend the emergency calls within 24hrs. of lodging any complaints. Kindly mention the address of service centre in Goa and phone numbers of contact persons clearly in your offer, else offer may not be considered. Kindly furnish details/Phone numbers clearly in your offer.



SPECIFICATIONS FOR RADIANT HEAT WARMER.		Technical Specifications offered by the Bidder
I. ELECTRICAL SPECIFICATIONS:		
1	Should be microprocessor based temperature controller with Pre-warm, Manual, Air, Skin Servo modes.	
2	Should have LED display of Skin temp, Set temp (Resolution 0.1° C) and Heater Power %.	
3	Should have LCD to display modes of operation, Alarm messages, Skin temp in °F and Timer.	
4	Should be Thermistor based sensor with Accuracy of +/- 0.2° C (Temp. calibration not required).	
5	Should have following modes of operation: Skin, Air, Servo, Manual and Pre-warm.	
6	Should have keypad lock facility.	
7	Skin mode: Temperature range should be 34 to 38 ° C and resolution 0.1° C.	
8	Manual mode: should have Adjustable heater power 0 to 100 % (with an increment of 5%); Time duration: 15mins.	
9	Pre-warm mode: used to Pre-warm the cradle before baby is placed on the bed. (No alarm will be activated during Pre-warm mode). Should have adjustable heater power 0 to 25% (with an increment of 5%); Time duration: 30 mins.	
10	Overhead FR-grade heater box should consist of Swivelling heater source for X-ray purpose and consists of Ceramic heater (650 watts) placed in parabolic reflector with a safety grill, with LED observation light for observing the baby.
