TECHNICAL SPECIFICATION

1.0. GENERAL

Mormugao Port Trust invite the quotation for the work of **“Periodical Load testing of cranes at Mormugao Port Trust”**.

2.0. SCOPE OF WORK

2.1 Every Lifting Appliances and Loose Gears shall be tested, examined and certified by a Competent Person, before being taken into use for the first time to ensure that it is of good construction sound material and of adequate strength for the purpose for which it is used and after it has undergone any alterations of repairs liable to affect its strength or stability and also once at least in every five years in the manner set out in Schedule-I [Regulation 41(1)] and Schedule-I [Regulation 47(1)].

2.2 After satisfactory completing of the testing and examination indicated above, the competent person shall enter the particulars of these tests in Part-I and Part-II of the Register of lifting appliances and loose gear and attach the appropriate certificates (in form-IV and V) to the register as per the Regulations 51 and 52(1). As such, the tenderer shall carry out this five yearly load testing in line with above Dock workers (safe, health and welfare) regulations, 1990 .

3.0. TECHNICAL SPECIFICATIONS

3.1 The details of cranes for Periodic load testing are given below.

3.2 The periodical load testing should be carried out to the satisfaction of the Engineer in charge.

3.3 All left over / scrap materials etc. are to be promptly cleared out from the work site by the Bidder at his own cost.

3.4 **Definitions :**

(i) **“Competent person”** means

(a) A person belonging to a testing establishment in India who is approved by the Directorate General Factory Advice service & Labour Institutes, Government of India, for the purpose of testing, examination or annealing and certification of lifting appliances, loose gear or wire ropes.

(b) Any other person who is recognized under the relevant regulations in force in other countries as competent for issuing certificates for any kind of purposes mentioned in sub-clause(i) for implementation of the protection against accidents (dockers) convention (revised), 1932 (no. 32) and the convention concerning the occupational safety and health in dock work (no. 152), 1979, adopted by International Labour Conference.

(ii) **Lifting appliances :** Means all stationery or mobile cargo handling appliances including their permanent attachments such as cranes, derricks, shore based power operated ramps used on shore or on board ship for suspending, raising or lowering cargo or moving them from one position to another while suspended or supported in connection with the dock work and includes lifting machinery.

(iii) **Loose gears :** Means hook, shackle, swivel chain, sling, lifting beam, container spreader, tray and any other such gear, suspended or supported in connection with the dock work and includes lifting the load can be attached to a lifting appliance and includes lifting device.

(iv) **Safe working load:** Means “safe working load” in relation to an article of loose gear or lifting appliance means the load which is the maximum load that may be imposed with safety in the normal working conditions and as assessed and certified by the competent person.

4.0 GENERAL TERMS AND CONDITIONS

4.1 Validity:

The validity period for the offer shall be 60 days from the date of opening of the quotation.

4.2 Price:

The offered rates shall be inclusive of all taxes and duties. Service Tax shall be paid as applicable. If, any new tax will be imposed by State/ Central Govt. and same will be reimbursed on producing documentary proof.

4.3 Completion Period:

The entire work shall be completed within **4 weeks** from the date of receipt of work order.

4.4 Payment Terms:

i. 100% payment shall be made on within **30 days** after satisfactory completion of work on producing invoice complete in all respect.

ii. The contractor shall furnish their bank account details for the payment through ECS by the Trust. A copy of the PAN card, Service Tax Registration no., EPF & ESI registration shall also be furnished. MICR number Name of the Branch along with Bill for arranging payment made through E.C.S. by the Trust.

4.5 Liquidated Damages:

In the event of failure by the contractor to complete the execution of the work within the time stipulated in the contract or by the expiry of any period of extension granted by the Board's terms thereof, the contractor shall pay the Board as Liquidated Damages for delay to complete the work, a sum of 1% of contract price per week or part thereof subject to a maximum of 10% and the Board shall have the power to deduct this amount from the payment of the amounts due to the contractor or from his deposit.

4.6 Other terms and conditions

i) All tools and tackles shall be arranged by the Contractor at their own cost.

ii) The Bidders is advised to visit the site and get acquainted regarding the nature of the work involved at site conditions before quoting the rate.

iii) The technical specification Schedule ‘A’, General terms and condition at Schedule ‘B’ and Schedule of prices and quantities Schedule ‘C’ to be read in conjunction to ensure the actual supply and works involved.

iv) Necessary Entry passes shall be obtained by the Contractor at their own cost with the approval of Port Officials.

v) The Trust will not be responsible for any loss or damage of the men/materials/tools/plants engaged by the firm during the work at site or transportation.

vi) The Contractor shall take utmost care during the execution of the work, if any damage to Port property, the cost of the damage shall be deducted from the Contractor's bill.
