TECHNICAL SPECIFICATIONS

Name of the Work: Annual Thorough Examination of lifting Appliances/ equipments at Mormugao Port Trust.

1 Scope of work

- 1.1 All Lifting Appliances and Loose Gears shall be thoroughly examined by a Competent Person atleast once in every 12 months. The particulars of these thorough examinations shall be entered in Part-I and Part-II of the Register as per the Regulations 41(2), 47(2), 51 and 52(1). As such the tenderer shall carry out this annual thorough examination in line with above regulations.
- 1.2 After Annual Thorough Examination of Equipments / lifting appliances, the competent person shall do endorsement on cargo/chain register for annual thorough examination.

2. TECHNICAL SPECIFICATIONS

2.1 The details of equipments/lifting appliances of Annual Thorough examination is given as below.

2.2 The Annual Thorough examination should be carried out to the satisfaction of the Engineer in charge.

3 Definitions:

- 3.1 "Competent person" means
 - (a) A person belonging to a testing establishment in India who is approved by the <u>Directorate General</u> <u>Factory Advice service & Labour Institutes, Government of India</u>, for the purpose of testing, examination or annealing and certification of lifting appliances, loose gear or wire ropes.
 - (b) Any other person who is recognized under the relevant regulations in force in other countries as competent for issuing certificates for any kind of purposes mentioned in sub-clause(i) for implementation of the protection against accidents (dockers) convention (revised), 1932 (no. 32) and the convention concerning the occupational safety and health in dock work (no. 152), 1979, adopted by International Labour Conference.
- 3.2 **Lifting appliances**: Means all stationery or mobile cargo handling appliances including their permanent attachments such as Cranes, derrick shore based power operated ramps used on shore or on board ship for suspending, raising or lowering cargo or moving them from one position to another while suspended or supported in connection with the dock work and includes lifting machinery.
- 3.3 **Loose gears:** Means hook, shackle chains, sling, lifting beam, container spreader, tray and any other such gear by means of which the load can be attached to a lifting appliances and includes lifting device.
- 3.4 **Safe working load:** Means "safe working load" in relation to an article of loose gear or lifting appliance means the load which is the maximum load that may be imposed with safety in the normal working conditions and as assessed and certified by the competent person.

4.0 GENERAL TERMS AND CONDITIONS

4.1 Validity:

The validity period for the offer shall be 60 days from the date of opening of the quotation.

4.2 Price:

The offered rates shall be inclusive of all taxes and duties. GST shall be paid extra as applicable.

4.3 Completion Period:

The entire work shall be completed within 01 week from the date of receipt of work order.

4.4 Payment Terms:

- i. 100% payment shall be made on within **30 days** after satisfactory completion of work on producing invoice complete in all respect.
- ii. The contractor shall furnish their bank account details for the payment through ECS by the Trust. A copy of the PAN card, Service Tax Registration no., EPF & ESI registration shall also be furnished. MICR number, Name of the Branch along with Bill for arranging payment made through E.C.S. by the Trust.

4.5 Liquidated Damages:

In the event of failure by the contractor to complete the execution of the work within the time stipulated in the contract or by the expiry of any period of extension granted by the Board's terms thereof, the contractor shall pay the Board as Liquidated Damages for delay to complete the work, a sum of 1% of contract price per week or part thereof subject to a maximum of 10% and the Board shall have the power to deduct this amount from the payment of the amounts due to the contractor or from his deposit.

4.6 Other terms and conditions

- i) All tools and tackles shall be arranged by the Contractor at their own cost.
- ii) The Bidders is advised to visit the site and get acquainted regarding the nature of the work involved at site conditions before quoting the rate.
- iii) The technical specification Schedule 'A', General terms and condition at Schedule 'B' and Schedule of prices and quantities Schedule 'C' to be read in conjunction to ensure the actual supply and works involved.
- iv) Necessary Entry passes shall be obtained by the Contractor at their own cost with the approval of Port Officials.
- v) The Trust will not be responsible for any loss or damage of the men/materials/ tools/plants engaged by the firm during the work at site or transportation.
- vi) The Contractor shall take utmost care during the execution of the work, if any damage to Port property, the cost of the damage shall be deducted from the Contractor's bill.
