I am directed to refer to this Ministry's letter of even No. dated 21.01.2015 on the subject mentioned above and to say that it has come to the notice of this Ministry that the instructions issued vide this Ministry's above letter dated 21.01.2015 have been misinterpreted by the CVOs of some of the organisations under this Ministry and made applicable in all promotion cases.

- 2. It is clarified that the instructions issued vide this Ministry's letter dated 21.01.2015 are applicable only in respect of selection posts of officers at the level of HOD/ Board Level and above in the Major Ports/ PSUs and other organisations under this Ministry. In so far as promotion cases are concerned, irrespective of the level of posts, DoPT's O.M. No. 22034/4/2012-Estt.(D) dated 02.11.2012 will be applicable with regard to vigilance clearance.
- 3. The CVOs in all the organisations under this Ministry are requested to strictly follow the DoPT's guidelines contained in their O.M. No. 22034/4/2012-Estt.(D) dated 02.11.2012 in respect of promotion cases and O.M. No. 11012/11/2007-Estt.(A) dated 14.12.2007 as modified by O.M. dated 21.06.2013 in respect of selection posts of officers at the level of HOD/ Board Level and above.
- This may be caused wide publicity and vigilance clearances issued accordingly.



Sir,

I am directed to refer to the subject mentioned above and to say that while forwarding the application for the selection of posts at HOD level and above in the Major Ports, the concerned administrative authorities are required to forward the applications with clear opinion regarding vigilance clearance with details of pending cases, Departmental Enquiries (DEs) and vigilance enquiries.

2. In view of the above, it is requested that the CVOs concerned may kindly furnish the vigilance clearance/status in respect of the officials concerned clearly indicating whether they are clear from vigilance angle or not on the basis of the Department of Personnel and Training guidelines dated OM No.11012/11/2007-Estt.(A) dated 14.12.2007 as modified by OM dated 21.06.2013 alongwith the vigilance status being sent in the proforma to this Ministry. The same procedure may be followed while giving vigilance clearance to the post at Board level in PSUs and other selection posts in attached and sub-ordinate/autonomous bodies, etc. under the Ministry of Shipping. While furnishing vigilance clearance in respect of officials concerned, if the official concerned is not cleared from vigilance angle, the reasons/grounds for denial / withholding of vigilance clearance shall be furnished to this Ministry.

3. In case the official concerned, in respect of whom the vigilance clearance is required, has worked in different organisations in last 10 years other than the present organisation, the CVO concerned has to obtain the vigilance status from the previous organisations and examine the consolidated status before furnishing clear vigilance clearance on the basis of the above guidelines of DoPT.
