You are requested to kindly furnish your firm quotation for the supply of items (cables, lugs, elmex terminals) **as indicated in the attached Annexure (18 items).**

**TERMS & CONDITIONS**

1. **PAYMENT:** Kindly note that we are an autonomous body under the Ministry of Ports, Shipping & Waterways and as such 100% payment shall be made within 30 days of receipt of undisputed material/invoice/documents by ECS/EFT. Suppliers Invoice should indicate the suppliers and MPA's GST numbers and suppliers HSN number.
  2. **DELIVERY:** The delivery period is within 6 weeks. The packaging shall be in eco-friendly material. You will have to dispatch the material to Depot Section, MM Division, Near Civil Maintenance Office, Mormugao Port Authority, Headland Sada 403804, Contact No. 0832-2594517.
  3. **VALIDITY:** Your quotation should be valid for 60 days from the date of opening.
  4. **LIQUIDATED DAMAGES:** Supply schedule as per order should be strictly adhered to. In the event of delay in supplies, Liquidated Damages at 0.5% of the total basic value of the undelivered quantity will be levied per week or part thereof of delay. The total Liquidated Damages shall however not exceed 10% of the total basic value of the order. The total value here means the total value of the order exclusive of taxes, freight etc. **The date of receipt of material at our Store at Headland, Mormugao, will be considered as date of delivery for the purpose of Liquidated Damages.**
  5. **FORCE MAJEURE & EXTENSION IN DELIVERY PERIOD:** In case of failure to deliver the goods in time which shall have arisen due to war, insurrection, restraint imposed by the Government Act or Legislation or other Authority, accident, strike, riot, lock-out or unforeseen events beyond human control directly or indirectly interfering with the supplies of stores or from any cause which the purchaser may admit as reasonable ground for an extension of time, the purchaser will allow such additional time he considers reasonable provided that the contractor shall report to the purchaser the occurrence of any cause as aforesaid which will or might affect the performance of the contract within a reasonable time. Requests for extension received after expiry of the delivery schedule will not be entertained.
  6. **SECURITY DEPOSIT:** The successful tenderer will have to effect a Security Deposit amount equal to 10% of the basic value of the order. The same will be deducted from the bill and retained till the expiry of warranty period.
  7. **WARRANTY:** One year. In case of any fault during the warranty period, the supplier will have to make arrangements to collect, repair/replace and return the item.
- NOTE:** Bidders has to accept all the clauses at Sr. Nos. 1 to 7 failing which the offers will be summarily rejected.

Kindly furnish your typed offer in sealed cover marked **"MM/NS/0135 due on 07/01/2026"**, which shall be opened on **07/01/2026 at 15.30 hrs.** The cover (offer) should reach this office latest by 15.00 hrs on the due date.




#### INSTRUCTIONS TO BIDDERS:-

- a. **Offers may be sent by e-mail with protected password.** The protected password of the e-mail shall be sent between 15.00 hrs. to 15.30 hrs. on **07/01/2026**, before the tender opening time on the official e-mail [mm@mpptgoa.gov.in](mailto:mm@mpptgoa.gov.in). Offers by e-mail without protected password will be summarily rejected.
- b. **Bidders may also send their offers by Courier Service or by Post** and ensure that the same is received by this office within the due date i.e. **07/01/2026** and time i.e. **15.00 hrs.**
- c. Bidders may also submit their offers in sealed envelope and drop the same in the Tender Box kept at the MPA Administrative Office Building, 2<sup>nd</sup> Floor, MM Division, by 15.00 hrs. on the due date. The offers to be put in Tender Box earmarked for the subject tender, indicating the relevant subject, tender number and due date. The offers will be opened on the due date i.e. **07/01/2026 at 15.30 hrs.** The offers, if dropped in the tender box not earmarked for the same i.e. a different tender box, the offer will not be considered.
- d. Offers received after the due date and time will not be considered.
- e. Each bidder shall submit only one bid per tender. A bidder who submits more than one bid will cause all the bids with the Bidder's participation shall be rejected.
- f. The bidders, if desire, may witness the bids opening at our premises on the due date **07/01/2026** at 15.30 hrs.
- g. Those bidders whose working/trade licence, GSTN, etc., are suspended, their offers will be summarily rejected.
