A. TECHNICAL SPECIFICATIONS:

1. Offers in single cover system are invited from the Valuer for the work of “VALUATION OF TUG TIRACOL II OF MORMUGAO PORT AUTHORITY”.

2. BACK GROUND

Mormugao Port Authority (MPA) is having 01 No TUG TIRACOL II. Details of TUG TIRACOL II is enclosed at ANNEXURE – I.

3. BRIEF DETAILS OF TUG TIRACOL II

Tug Tiracol-II was acquired in the year 2003 and was extensively used during routine Port operations and the tug has completed 22 years.

Mormugao Port Authority intends to carryout valuation of Tug Tiracol-II.

B. SCOPE OF WORK OF THE VALUER:

- a) The information provided at para 3 above is only to get a general idea of the Tug and is not exhaustive. Appointed Valuer is required to visit the site with advance intimation to the MPA and carry out detail assessment of the Tug at their own cost and submit the Report of valuation in a sealed cover. Tug Tiracol-II is available at Port craft jetty of MPA.
- b) Completion Period: The valuation work including submission of valuation Report shall be carried out within 10 working days from the date of issue of work order.
- c) All tools and tackles, instruments and manpower required for the purpose shall be arranged by the appointed Valuer.
- d) The appointed Valuer shall make his own arrangements to travel to MPA including lodging and boarding during the duration of the work.
- e) Conveyance for movement within the site shall be arranged by the appointed Valuer at his own cost. The Port will arrange required gate passes for entry to the Port area, free of cost, if required.
- f) Validity of offer shall be 120 days from the date of opening of the bid.
- g) Rate: The bidder shall quote the price as per the price schedule format enclosed. The charges quoted shall be firm and shall include lumpsum fee inclusive of travelling, lodging & boarding expenses, out of pocket expenses viz. typing, printing, etc., all exclusive of GST, to carry out the valuation work and submit valuation Report as per scope of work. The price basis shall be firm, with no escalation provision whatsoever.

C. ELIGIBILITY CRITERIA OF BIDDERS:

Following documents shall be submitted by the bidder along with the Bid, failing which the bid will not be considered further,

The bidder should have experience in carrying out valuation of marine crafts in Central/State Govt. organisations, Ports, PSU's or any other reputed firms/companies/ organisations. Documentary proof for the same to be submitted along with the quotation.

D. PROCEDURE FOR SUBMITTING THE BIDS:

- a) The entire quotation document shall be downloaded from the Port website. All the pages to be stamped and signed and then submitted along with the offer.
- b) Bid with any counter conditions will not be considered for evaluation.
- c) The quotation complete in all respects, in a sealed cover superscribed as "VALUATION OF TUG TIRACOL II OF MORMUGAO PORT AUTHORITY" should reach the undersigned on or before 12.01.2026 by 1430 hrs, and will be opened on the same day at 1500 hrs.

E. AWARD CRITERIA: MPA will award the assignment to the successful Bidder, whose bid has been determined to be substantially responsive and has been determined as the lowest evaluated bid. MPA shall be the sole judge in this regard. MPA reserves the right to reject any bids without assigning any reason whatsoever.

F. GENERAL: - If the work is not completed within the stipulated period of 10 days, the Port has the right to withdraw the work and entrust the same to the other party.

G. PAYMENT TERMS:

- a) 100% payment will be made after acceptance of valuation Report to the entire satisfaction of MPA authorities within 30 days from the date of submission of undisputed Bill, in triplicate.
- b) The contractor shall furnish their bank account details for the payment through ECS by the Authority. A copy of the PAN card, GST Registration no., shall also be furnished.

H. TAXES AND DUTIES: MPA shall be entitled to deduct applicable tax (if any like income tax) at source as per Indian Laws from the payments due to the Valuer under the contract.
