**OFFER OF TEMPORARY ENGAGEMENT**

\_\_\_\_\_ is hereby given offer for enlistment as “**Pharmacist**” (**on Visiting Basis**), for empanelment in MPT Hospital, on the terms and conditions stipulated below:-

**TERMS & CONDITIONS FOR PHARMACIST (ON VISITING BASIS)**

1. The engagement is purely on visiting basis. The engagement shall not confer on his/her any right or claim for regularization in the Port services against any vacant post whatsoever. The engagement will be for a period of 11 months. The empanelment is renewable at discretion of the Dy. Chairman.
2. He/She should visit the MPT Hospital, Headland Sada, for 6 visits in a week, for full day from 08.00 A.M. to 01.00 P.M. & 02:00 P.M. to 05:00 P.M from Monday to Friday and on Saturday 08.00 A.M. to 01.00 P.M or as per such alternative schedule as may be fixed in consultation with him/her from time to time.
3. He/She shall be paid a consolidated salary of Rs.24,000/- (including weekly offs) per month from the date he/she takes over charge of the post. He/She shall not be entitled to any other service benefits as applicable, to other regular employees of the Port. Further, he/she shall be not entitled for any kind of holiday.
4. He/She will be permitted to avail Casual Leave on pro-rata basis @ of 1.25 day for each completed calendar month of contract service. CL will be sanctioned by the Chief Pharmacist/Chief Medical Officer. .
5. He/She shall be entitled to free medical treatment in the Mormugao Port Trust Hospital during her contract period to the extent the facilities are available in house for self only.
6. He/She should make her own arrangement for conveyance to visit Port Trust Hospital.
7. He/She shall be under the administrative control of the Chief Medical Officer of the Mormugao Port Trust and shall act under his supervision.
8. His/Her services shall be terminated by giving one month notice on either side during the subsistence of the contract.
9. In the event of any disputes, arising out of this contract, the interpretation and decision of the Dy. Chairman of the Mormugao Port Trust will be final and binding.
